**USFSP Faculty Enrollment Management Committee  
Minutes for October 5<sup>th</sup>, 2010**

**Present:** Stephen Danese, Bonnie Braun, Sheila Goethe, Jerry Notaro, Barnali Dixon, Jennifer Quinn-Taylor, Holly Kickliter, Linda Crossman

Chair, Jerry Notaro, called the meeting to order at noon.

Introductions and Welcome to new members.

It was moved by Stephen Danese and seconded by Linda Crossman that the minutes of April 5, 2010 be approved. Minutes were discussed and approved as distributed.

**NEW BUSINESS:**

1. Linda Crossman reviewed the USF Tampa Undergraduate Studies Advisory Committee proposed "System Level Policy" changes, as well as USFSP's proposed response to the changes. The committee discussed these proposed changes in depth and had the following recommendations/changes (**bold**) for the USFSP Response:
  - a. M Grades: ***If a grade is not submitted, an "M" is automatically assigned. Until replaced, the "M" remains on the academic record and is not computed in the GPA.*** (This sentence was re-worded)
  - b. Academic Renewal I: *When ARI students return to USFSP, they are classed as beginning juniors with **no more than 60.0 credit hours** and the GPA calculation starts from that point (fresh start).* (This bolded section was added)
  - c. Academic Renewal II: *ARI requires students to provide convincing evidence of changes that indicate they will be **academically** successful given a new opportunity.* (This word was added)
  - d. Course Repeats: ***This policy does not apply to a student who withdraws from the university for a term.*** (This sentence was re-worded)

Bonnie Braun moved that the committee accept USFSP's response to the policy changes proposed by USF Tampa, with the addition of the committee changes. Jennifer Quinn-Taylor seconded the motion. The motion passed.

2. Holly Kickliter presented a brief report on the 2010-11 application, admits and enrollment figures of new students as of October 4, 2010. See attached report.
