Introduction of writing tutorials for essay and research paper assignments.	The Political Science ALC in 2012 and 2013 (Section 2.a – Written Communication Skills) found that students needed help with writing organization and citation format.	In response, the political science faculty set out to improve written communication skills by introducing writing tutorials. Some faculty have opted to take students to the library for formal writing & research workshops, while other faculty have instituted in-class tutorials.

POS 3691 – Introduction to Law & Politics. Transition from face-to-face to hybrid.	Prior to 2014 the Political Science program offered one on-line course. Some students had asked for greater flexibility in course options.	Review by department executive committee.	In early 2014 the department executive committee reviewed a proposal to offer POS 3691 - Introduction to Law & Politics as a hybrid course. The class had previously been taught exclusively face-to-face. The committee examined the course content and learning outcomes and found them equivalent to the face-to-face class. The course was reviewed again after it was taught to assess student achievement (see 2015-2106 discussion below).

The hybrid class was taught for the first time in Spring 2015. On April 4, 2016 the department executive committee reviewed the course as part of its annual review

			process. Enrollment in the hybrid course was lower than face-to-face, but the course content and student learning matched that of previous versions of the class. The instructor narrative and student evaluations suggested that the level of student achievement was maintained.
