ENC 3350 - Advanced Writing Studio

Advanced Writing Studio is a one-hour elective for upper-division students working toward disciplinary publication. Students receive one-on-one feedback on their writing in small group, workshop context.

ENC 1146L - Writing Studio Lab

Writing Studio provides additional support for writers working in disciplinary courses, as a one-hour elective where students workshop writing projects assigned in classes around campus. Students receive one-on-one feedback in small group writing workshop

Journalism and Media Studies curriculum change

JOU 3346C - Multimedia Reporting

The course prepares students for a digital media environment. Students learn to write, report, as well as produce audio, video, photos, and digital content for news stories. Students produce multimedia news stories for the web. It will be a core class replacing MMC 4420 Research Methods.

JOU 4111 - Advanced Reporting

Students learn to produce quality high quality media content and news feature stories for publication. Students write stories, practice news gathering, produce digital clips for portfolios and possible entries in the Hearst Journalism Awards Program. It will be a core class replacing JOU 4201 News Editing.

JOU 4938 - Senior Capstone Seminar

All USFSP journalism majors are required to take this capstone course, which teaches to produce specific job search materials, including a résumé and cover letter, produce an online portfolio of your work, practice job interview and networking skills. This class already on the schedule as a required core class. The only thing that changes is the number of credit hours, from 2 to 3.

Request to have a correct workable state course number or because the course is owned by Tampa ask for variable course numbers (range of 2-3 credit hours)

Proposed Changes to Global Business Major

- 1) 3 of 4 required courses for major changed to include courses regularly taught as part of other majors in the College
- 2) Several changes to the list of Global Business Elective courses
- 3) GEB 4941 was added to the list of courses to count towards the Global Cultural Experience
- 4) Language was added to be allowed to substitute for global work experience and an additional 3 credit hours of elective courses for the experience requirement
- 5) Language was added to limit the number of internship, selected topic, and independent research credit hours that can count towards the major as well as language concerning where these types of courses can be taken and the transferring of courses in from other USF System institutions

Proposed Changes to Entrepreneurship Major

- 1) For ENT 3013 New Venture Creation: Remove MAN 4802 as the sole prerequisite for this course.
- 2) For ENT 4214 Entrepreneurial Leadership: Remove MAN 4802 as a prerequisite and replace it with ENT 3004 Principles of Entrepreneurship
- 3) For ENT 4945 Student Consulting in High Growth Ventures:” Remove ENT 3013, ENT 4244, and MAN 4802 as prerequisites for this course. This course will now have the following two prerequisites: ENT 3004 Principles of Entrepreneurship and ENT 3613 Creativity and Innovation.
- 4) Replace ENT 4943 Internships in Entrepreneurship (1-3) with GEB 4941 Internship (1-3) BP GEB. GEB 4941 is the broadly used internship course for the KTCOM students. Delete ENT 4943 Internships in Entrepreneurship from the course catalog as this specific internship will no longer be needed for the major.

Proposed Changes to Accounting Major

- 1) Remove ACG 4123 Intermediate III from Generalist Emphasis, CPA Emphasis, and Audit Emphasis (course discontinued).
- 2) Beneath CPA Emphasis, remove Requires 3 Hours.
- 3) Move ACG 5675 Internal and Operational Auditing from Generalist Emphasis to Audit Emphasis
- 4) Remove BUL 3321 as elective under CPA Emphasis
- 5) On Catalog description add, “ACG 4931 Special Topics in Accounting and ACG 4940 Accounting Internship are acceptable electives. ACG 4940 can only be taken once for credit towards the accounting major and only ACG 4940 OR ACG 4931 IRS VITA Tax Practicum can be counted towards the major but not both. Florida requires 24 hours of upper level accounting courses to sit for the CPA exam.”

- 2) Addition of a new course (recently added to USF Tampa System) that will be a required course for USFSP students majoring in Finance and choosing to pursue the “Personal Financial Advising” FIN Concentration: FIN 4128 Financial Planning Process and Development

- 3) Addition of a new course (recently added to USF Tampa System) that will be a required course for USFSP students majoring in Finance and choosing to pursue the “Investment Advising” FIN Concentration: FIN 4533 Derivatives
- 4) Focus the Financial Curriculum on three new career-focused Financial Concentrations: 1) Investment, 2) Personal Financial Advising, and 3) Corporate Finance. This is to better prepare KTCOB students majoring in Finance for specific career tracks.
