Mrs. Minkoff called the Hearing to order at 5:07 PM to hear public comment on the Juvenile Welfare Board's 2012-2013 Budget.

**RESOLUTION FY 12-13- 1**

**TENTATIVE HEARING**

**A RESOLUTION OF THE JUVENILE WELFARE BOARD OF PINELLAS COUNTY, FLORIDA, ADOPTING THE TENTATIVE LEVY OF AD VALOREM TAXES FOR THE JUVENILE WELFARE BOARD FOR FISCAL YEAR 2012-2013.**

**WHEREAS**, the Juvenile Welfare Board of Pinellas County, Florida on September 13, 2012, adopted Fiscal Year 2012-2013 a Tentative Millage Rate following a public hearing as required by Florida Statute 200.065.

**WHEREAS**, the Juvenile Welfare Board of Pinellas County, Florida held a public hearing as required by Florida Statute 200.065; and

**WHEREAS**, the Gross Taxable Value for Operating Purposes not exempt from taxation within Pinellas County has been certified by the County Property Appraiser to the Juvenile Welfare Board as \$54,425,420,037.

**NOW, THEREFORE, BE IT RESOLVED** by the Juvenile Welfare Board of Pinellas County, Florida, that:

1. The Fiscal Year 2012-2013 operating millage rate for the Juvenile Welfare Board is .8981 mills which is greater than the rolled-back rate of 0.8532 mills.
2. This resolution shall take effect immediately upon its adoption.
